Table A is used to assess fees for new commercial, commercial add-ons and alterations, residential alterations, apartments and buildings with four or more dwelling units per building.

\$500,000 and up	\$1,816 for the first \$500,000 plus \$2.00 for each additional \$1,000 or fraction thereof

Demolition (residential)	\$25.00
Demolition (commercial)	\$100.00
Residential New Construction and Additions (enclosed area)	\$0.10 sq ft
Residential Carports and Storage Buildings (under 800sq ft)	\$0.04 sq ft
Residential Garage Enclosures	\$0.05 sq ft
